#### **Description of Activities/Observations:**

- **Surveys:** The major activity consists on conducting surveys with importers, exporters, and local wholesalers of rice, maize, tomato, plantain, and any processed forms of these goods. Surveys were administrating using questionnaires with the technical support of the “*Observatoire des marchés agricoles*”, a government institution in charge of assessing agricultural markets across Mali in terms of volume of imports and exports, trends in prices; and together with the ministry of trade, APECAM, and Chamber of commerce and industry of Mali, formulate policies aiming at improving domestic and international trade and market strategies in order to ensure food security across the country.

Surveys were also conducted with local traders of rice and maize in Bamako market and also with wholesalers in Baguineda and Niarela markets.

Statistics on Imports and Exports over years for rice, maize, tomatoes and plantain were obtained at the National Institute of statistics (INSAT)

- **Interviews:**

- with key informants at ANSSA, OPV and SPS focal points to address SPS regulations issues in Mali regarding procedures of inspection of importing and exporting agricultural goods, different types of certificate required for imports and exports, standards used for exporting products, SPS measures for importing products. Documents such as texts, acts, SPS regulations, or policy brief were also collected.
- with key informants at DNCC (department of trade, Ministry of commerce); APECAM, and chamber of commerce and industry of Mali, on acts and laws that regulate imports and exports in Mali.
- with IICEM agents to gather information about the structure and conduct of vegetable markets across the country.
- with professional associations of exporters to get the list of importing countries and to understand regulations and standards required by these countries.
